- Your application must include copies of all licenses and/or permits necessary for the types of products you are planning to sell (please refer to the attached Farmer's Market Federation of New York guidelines). This includes any Board of Health permits, beer and wine licenses, and nursery licenses with your signed application.
- All Vendors are required to provide proof of liability insurance. Waiver of Liability forms will not be accepted. The Farmer's Market Federation recommends checking liability insurance rates through a co-op offered by Campbell Risk Management. - As a vendor wishing to rent space at the Chestnut Street Farmer's Market, I agree to save, hold harmless, and indemnity St. John's Evangelical Lutheran Church, its sponsoring agency, members and employees located at 502 West Chestnut Street, Rome, NY 13340, from all liability or responsibility pertaining to any damages to persons or property on the site leased by me from said market, when such damages and/or liability arise out of any acts of my own, or of my employees or associates.
